The Department of Building Construction, Govt. of Bihar, Patna invit application for the post of Assistant Architect for appointment on Contract Basis follows:

GENERAL CONDITION:

1. Reservation policy, as approved and followed by the Government of Bihar will apply to this Advertisement and Reservation to Women, Gram Sons/Grand Daughters/Maternal Grand Sons/Maternal Grand Daughters Freedom Fighters, PHP (Physically Handicapped Persons) Candidates and Women (BC) Category will be given in accordance with the Govt. of Bihar norms.
2. The recruitment will be on contract basis firstly for a period of one year till the regular appointment is made to the mentioned post (whichever comes earlier). At a time the contract may be renewed for the next year based on satisfactory performance & conduct of the candidate at the discretion of the Department, if deemed necessary by the Department in the exigencies of the work of the Department.
3. The cutoff date for age is calculated on-01.08.2017. Upper age limit shall be as per the policy of the Govt. of Bihar. (UR-37 years, MBC & BC-40 years & ST-42 years)
4. Application of Candidates below the age of 22 years will not be accepted.
5. If any of the certificates (viz.-educational qualification, work experience certificate, age-proof certificate, residential certificate, caste certificate) are found false/forged/invalid or fake, then not only contract of such candidate will be terminated forthwith but criminal proceeding shall be initiated against him/her and the consolidated remuneration paid to such candidate during the period of contractual appointment will be recovered from such a candidate.
6. (a) The candidates appointed on contract basis will not be treated as Government Servants. After the recruitment, they will not be entitled for

regularization of their services under the Govt. of Bihar on the basis of their contractual services under the Department.

- (b) Except for 12 Annual casual leave, no other leave will be admissible.
- (c) If the contract is not renewed before its expiry, such appointment will automatically stand terminated. No notice will be required for such termination.

7. **MODE OF SELECTION:** Candidates, short-listed on the basis of the following Evaluation Criteria, will be called for documents verification and interview.
(For total 100 marks)

I. Educational Qualification Criteria:

- a. Matric:- Max 10 Marks, 2nd division - 5 Marks, 1st division - 10 Marks
- b. Intermediate:- 2nd division - 5 Marks, 1st division - 10 Marks
- c. Degree in Architect:-
 - Below 60% Marks - 40 Marks
 - Above 60% and below 75% Marks - 50 Marks
 - 75% and Above - 60 Marks
- d. Higher Degree - i.e M. Arch. etc. – Max 20 Marks

II. Required documents such as i. Matric Certificate for age proof ii. Inter/10+2 Certificate, iii. Marks sheet of Architecture Degree Course iv. Passing certificate of Architecture Degree, v. Up-to-date Registration Certificate with council of Architecture, vi. Caste and Creamy Layer Certificate issued by competent authority, if reservation benefit claimed, vii. Permanent Domicile of Bihar Certificate, if claim reservation and any other certificates will be produced at the time document verification.

- c. The applicants are required to apply "ON LINE" on Departmental Website www.bcd.bih.nic.in. The Website will be open from 11.11.2017 to 11.11.2017, 2017. After filling-in ON-LINE application, Candidates will have to take a print-out of the application for their future reference.

j. Print a copy of finally submitted application form for future reference.


11. **GENERAL INSTRUCTIONS:-**
