
The candidates willing to apply for the above assignment should submit the duly filled online application form at the website <http://urban.bih.nic.in>. Online Applications can be submitted on the portal from 7th March, 2016 to 28th March, 2016 (upto 05:00 PM). All related documents must be uploaded in scanned form. Reservation roster shall be followed for all posts as per Government of Bihar Rules.

The applications will be evaluated on pre-determined evaluation criteria and the merit list will be prepared accordingly. The shortlisted candidates will be invited for counselling by ULBs where the claimed qualification will be verified with the documentary proof such as marks sheet, degree certificates. If the shortlisted candidates fail to prove the claimed qualification, they will be declared ineligible.

A candidate can apply in ULBs of only one district.

The initial maximum period of contract will be 11 Months. Further extension of Contract will be subject to good behaviour and minimum annual collection of Rs. 30.00 Lakhs by the person. This is purely commission based engagement. Candidates shall not claim for any Govt. /ULB job on the basis of this assignment.
